# Roll Call

9:05 – 9:10 am WISE Project Update – Anthony Valterra, WISE Project Manager Anthony provided the board with an update on the WISE grant. The update included:

- 1. U. S. Department of Labor Audit findings:
  - a. Disclosure updated to include percentage of program costs covered by WISE.
  - b. Policies and Procedures manual and FERPA acknowledgement updated to include additional entities with access to student files.
  - c. The correct DOL EEO poster now hangs in WISE grant class areas.
  - d. Equipment policy now specifies that all equipment paid for by the grant is secured physically.
  - e. Outcome Projections the grant projections are to meet or exceed deliverables.
  - f. All grant contracts have been updated to end on the last day of the grant.
  - g. Overall the grant is very strong and these corrections are minimal.
  - h. The grant auditor praised the grant for its strong leadership and industry partnerships.
- 2. Current grant outcomes and projections:
  - a. Grant outcomes overall the grant is on track to meet or exceed all grant outcomes. Anthony summarized current grant participant outcomes and projections. (See attachment 1). Anthony mentioned that employment numbers and wage increase numbers will likely increase when we receive ESD data.

Todd Currier suggested that the grant calculate the percentage of exiters that become employed.

Barbara explained that the Grant just recently completed ESD data sharing agreements, and this was a major challenge of the grant.

Todd Currier asked what outcome numbers the grant auditor was looking at.

- 3. Grant Budget Projections Overall the grant is slightly underspent. Some colleges are significantly underspend and some grant funds will likely be redistributed. Anthony also explained how new budget modifications will work going forward. Specifically, all colleges other than Centralia will become contractors under Centralia's budget. This allows funds to be moved more easily between consortium colleges.
- 4. New WISE Funded Programs
  - a. James Hovis, Centralia College Program Mgr described the RETC Lean Six Sigma program for Veterans accomplished through expanding the RETC Veterans contract
  - b. Anthony described the energy tech program at Shoreline College that will now be included in the WISE programs.
  - c. Walla Walla will expand their WISE funded programs to include an additional energy program.

Jesse Cote suggested that the final report include a section that covers the industry, education, and labor partnership.
